


Description

The MC78XX/LM78XX/MC78XXA series of three terminal positive regulators are available in the TO-220/D-PAK package and with several fixed output voltages, making them useful in a wide range of applications. Each type employs internal current limiting, thermal shut down and safe operating area protection, making it essentially indestructible. If adequate heat sinking is provided, they can deliver over 1A output current. Although designed primarily as fixed voltage regulators, these devices can be used with external components to obtain adjustable voltages and currents.




Figure 1. Quiescent Current





Figure 2. Peak Output Current

Figure 3. Output Voltage




Figure 4. Quiescent Current




Figure 5. DC Parameters




Figure 6. Load Regulation




Figure 7. Ripple Rejection





Figure 8. Fixed Output Regulator





Figure 11. Adjustable Output Regulator (7 to 30V)




Figure 12. High Current Voltage Regulator




Figure 13. High Output Current with Short Circuit Protection




Figure 14. Tracking Voltage Regulator



Figure 15. Split Power Supply ($\pm 15V-1A$)

Figure 16. Negative Output Voltage Circuit





Figure 17. Switching Regulator


